GLOBALTEC's corporate actions and commitments

1. Develop and implement comprehensive water strategies that are socially equitable, environmentally sustainable and economically beneficial in watersheds around the company's operations and supply chain.
2. Protect and/or restore water-based ecosystems in its own operations and in its supply chain.
3. Address the impacts that the operations by the company and its supply chain have on local water supplies, and support stakeholders to provide safe drinking water and ensure basic sanitation.



Goal 7

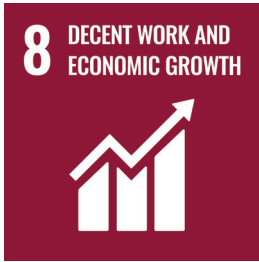
GLOBALTEC advocates sustainability in all its projects, promoting renewable energy and preventing environmental degradation.

Goals

GLOBALTEC's corporate actions and commitments

1. Significantly increase energy efficiency, obtain the remaining energy needed from renewable sources and promote these same actions throughout its supply chain by selecting and supporting suppliers.

GLOBALTEC's corporate actions and commitments


1. Line up private sector financing to support sustainable development initiatives in developing countries.
